Official Rules for the 2024 Car Raffle of the 2024 Jeep Grand Cherokee Limited sponsored by the Cancer Wellness Center.

The Cancer Wellness Center is a 501(c)(3) charitable organization located in Northbrook, IL. The Cancer Wellness Center (CWC) is here to help anyone touched by cancer find a way forward. Each year, our free counseling services, support groups, and health and nutrition programs serve over 1,800 community members of all ages and backgrounds. People with cancer, family members, friends, and caregivers all come to us to connect and cope.

With guidance from a caring team of professionals and comfort from a participant community who gets it, our holistic services offer a space to make sense of the diagnosis that changed your life — and navigate whatever comes next.

TICKET PRICE

The purchase price of a single raffle ticket is \$100 each or \$275 for 3 tickets. Checks or money orders should be made out to the Cancer Wellness Center. A "purchase" shall not occur and be binding on the Cancer Wellness Center until funds received have cleared the bank. Accepted credit cards include Discover, Visa, MasterCard and American Express. Tickets may be purchased online at www.Cancerwellness.org, or by phone: 847.509-9595, by mail or in person at CWC, 215 Revere Drive, Northbrook, IL 60062. Ticket purchases are not tax deductible or refundable. Each raffle ticket purchased shall constitute an "entry" into the raffle, and the person to whom the raffle ticket is registered shall be the "Entrant." Although more than one name may be provided on the ticket registration form, the ticket shall be registered to the first name listed, who shall constitute the sole Entrant for that ticket.

QUANTITY OF TICKETS

The maximum number of tickets offered for sale is 1,500. Requests for ticket purchases (and therefore payments received) after all tickets are sold or following the drawing, will be returned to the buyer(s).

ELIGIBILITY

Purchasers of raffle tickets must be legal residents of the United States and 18 years of age or older on, or before, Friday, December 20, 2024, for the Car Raffle Drawing. If an Entrant's check or credit card is dishonored prior to the drawing, the entry ticket will be declared invalid, until a replacement is received. All check or credit card charges found declined after the drawing must be honored. A \$30 charge will be assessed for non-sufficient funds or stop payment checks. Void where prohibited by law.

DRAWING

Completed requests must be in the possession of CWC (215 Revere Drive, Northbrook, IL 60062) by 5:00 PM CT on December 17, 2024, unless otherwise personally delivered to an authorized representative of CWC before the time of the drawing. The raffle will take place on Friday, December 20, 2024, with a random drawing. The winner, if not present, will be notified within 7 business days. It is the responsibility of the purchaser to provide a valid, deliverable mailing address, phone and/or email address for notification.

PRIZES

The winning Entrant shall be the "winner" of the prize. Payment to or delivery of any prize will be made to the Entrant. It is the sole responsibility of the Entrant to allocate a winning prize to other participants in case of a multiple entry registration, and the winning Entrant shall hold harmless the Cancer Wellness Center in case of conflicting claims or disputes among multiple claimants. Within 7 days from notification, the prize winner must inform CWC which prize they have selected. The winner must supply their social security number before the prize is tendered. The winning ticket holder is responsible for all taxes and fees, including, but not limited to federal, state and local income, sales and/or excise taxes, fees, assessments and like charges associated with the prize, including license, title and registration fees. Winner must complete a W-9 form before receiving prize. If the winner chooses the cash prize, the winner must process the prize payment within ninety (90) days of receiving notice they have won. CWC is not responsible for lost, delayed, misdirected, or returned prize notifications and payments. The Cancer Wellness Center may substitute a prize of equal value if an advertised prize becomes unavailable for any reason. If the 2024 Jeep Grand Cherokee Limited is not available (due to supply chain issues) when raffle winner is chosen on December 20, 2024, then CWC reserves the right to award the cash prize. At the time of this printing, federal law requires that a tax withholding on certain prize values must be collected from winners upon award and distribution. Federal and state withholding laws are subject to change without notice. The withholding laws in effect at the time the prize is claimed will be followed. Winners of prizes over six hundred dollars (\$600) will receive a W-2G from CWC. Taxes will be withheld in accordance with IRS and State of Illinois guidelines. In the event a winner: (a) does not notify CWC within seven (7) days of the drawing; (b) is ruled ineligible for any reason; (c) refuses the prize; or (d) does not return requested documents, the prize will be forfeited and will be retained by CWC for charitable use. The winner will have a choice of a 2024 Jeep Grand Cherokee Limited or \$30,000 in cash. If the winner chooses the vehicle, the winner will receive the advertised 2024 Jeep Grand Cherokee Limited from Marino Chrysler Jeep Dodge Ram

and must contact Marino Chrysler Jeep Dodge Ram within fourteen (14) days of the drawing. The winner may have the option to choose a different 2024 Jeep Grand Cherokee Limited vehicle, at the discretion of Marino Chrysler Jeep Dodge Ram and their available inventory. If the winner enters into an agreement with Marino Chrysler Jeep Dodge Ram to select a different vehicle than the 2024 Jeep Grand Cherokee Limited advertised in the raffle promotion, the winner will be responsible for paying any additional costs incurred. Any liability of the Cancer Wellness Center shall be limited to the ticket price paid. In the case of a dispute, CWC's decision shall be final. Entrant agrees to allow the Cancer Wellness Center to use their name and image without any compensation for any promotional activity related to this or any future raffle. Any and all addresses and contact information of the purchaser will not be released to the public. By purchasing a raffle ticket, you agree to be bound by these rules and the decisions of CWC which shall be binding and final as to all matters related to the raffle. The raffle and these official rules shall be subject to and governed by the laws of the State of Illinois. If a court of competent jurisdiction finds that any provision of these official rules, or their application to a particular persons or circumstances, is invalid or unenforceable to any extent, then the remainder of these official rules shall remain enforceable to the fullest extent permitted by law.
